- At the discretion of Tex-Con, any account that becomes past due may be placed on a "Hold" status, and/or the terms may be changed to "COD" until the account is paid to current.
- Should the customer default on any obligation to Tex-Con, customer agrees to pay, in addition to the principle balance, the following: late fees (finance charges) accrued at the rate of 1.5% of past due balance per month, reasonable attorney fees, and all costs of any nature incurred by Tex-Con to pursue the delinquent obligation. Payments will be applied to interest first, then to the principle balance.

Electronic Funds Transfers Agreement and Disclosure

This Electronic Funds Transfers Agreement and Disclosure is the contract which covers your and our rights and responsibilities concerning the electronic fund transfers (EFT or E-Z Pay) services offered to you by Hays City Corporation dba Tex-Con Oil Company. In this Agreement, the words “you,” “your,” “yours,” “we,” “my,” “our,” and “I,” mean those who sign the application as applicants. Electronic fund transfers are electronically initiated transfers of money from your account through the EFT services. By Signing an application for E-Z Pay, each of you jointly and severally, agree to the terms and conditions in this Agreement and any amendments to the EFT services offered. We understand the transaction date will be 10 days after purchase date for bulk deliveries and all other products. I (we) understand the transaction dates will be the 10th and the 25th of the month for all fuel access (CFN/Fuelman) Fleetwide card transactions

- FEES AND CHARGES** – There are certain fees and charges for EFT services. If an authorized EFT (E-Z Pay) payment is returned, you will be responsible for the EFT returned charge. We will notify you of any changes as required by applicable law. You further understand that should your account become delinquent, Tex-Con Oil Company has the right to refuse service and deliveries without notification. Any unpaid balance will accrue interest at the rate of 1.5% per month.

- NOTICE OF VARYING AMOUNTS** – Invoices rarely are the same amount, therefore by signing this agreement we are authorizing Tex-Con Oil to draft the appropriate amount needed to satisfy any invoices.
- CUSTOMER LIABILITY** – you are responsible for all transactions you authorize using your EFT (E-Z Pay) service under this Agreement. If you permit someone else to use an EFT service, you are responsible for any transactions they authorize or conduct on any of your accounts. However, TELL US AT ONCE if you believe your account information has been lost, stolen or if you believe someone has used your account information without your permission, or if you believe that an electronic fund transfer has been made without your permission using information from your check.
- RIGHT TO RECEIVE DOCUMENTATION** – you will receive, at a minimum, monthly statements which will reflect incurred invoices for the month that your E-Z pay transactions have/will pay. Additional copies of individual invoices are available through our portal www.texconoil.net for your review at any

time. If a login has not been set up to access Tex-Con Oil’s portal you can request that by telephoning Tex-Con Oil or emailing the credit department.

6. **TEX-CON LIABILITY FOR FAILURE TO MAKE TRANSFERS** – if Tex-Con Oil does not submit a transfer to your account on time or in the correct amount according to our agreement with you, we may be liable for any losses or damages. However, we will not be liable for direct or consequential damages in the following events:

- If, through no fault of ours, there is not enough money in your accounts to complete the transaction.
- If the information provided to us is incorrect
- If circumstances beyond our control (such as fire, flood, or power failure) prevent the transaction.
- If the electronic transfer is not completed as a result of your willful or negligent use of your EFT facility for making such transfers.

7. **TERMINATION OF EFT (E-Z PAY) SERVICES** – You or Tex-Con Oil may terminate this Agreement at any time by notifying us orally or in writing. Whether you or Tex-Con Oil, terminates this Agreement, the termination shall not affect your obligations under this Agreement for any electronic transactions made prior to termination.

8. **ENFORCEMENT** – You are liable to us for any losses, costs or expenses we incur resulting from your failure to follow this Agreement. You authorize us to deduct any such losses, costs or expenses from your account without prior notice to you. If we bring a legal action to collect any amount due under or to enforce this agreement, we shall be entitled, subject to applicable law, to payment of reasonable attorney’s fees and costs, including fees on any appeal, bankruptcy proceedings, and any post judgement collection actions.
